NRA Open Rifle Sectionals

The NRA Sectionals are major matches that are shot at several locations throughout the country. The NRA takes the results of these local matches and produces a national result bulletin. In these matches the juniors compete against adults, including members of the Army Marksmanship Unit. Against hundreds of shooters, we won 11 individual awards, 3 team awards and teamed with 2 former members for a share of 3 more team awards. Juniors who shoot at least one match were Megan English, Conlan McGough, Ryann McGough, Bobby Oberle, Joe Oberle (shooting his first NRA match), Tim Sherry, Chiara Trisdale, and Samantha Trisdale. They were joined by former members Taylor Beard and Scott Franz.

In the NRA 3-position smallbore match, Tim Sherry was 5th Marksman and Bobby Oberle was 7th Marksman.

In the NRA 4-position smallbore match, Tim Sherry was the 7th Marksman, Bobby Oberle was the 7th Marksman and Megan English was the 8th Sharpshooter. The Megan, Scott, Taylor and Tim were the 1st Expert team.

In the International 3-position smallbore match, Megan was the 1st Marksman. Bobby, Chiara, Ryann and Sam were the 1st Sharpshooter team and Megan, Scott, Taylor, and Tim were the 1st Expert team.

The International Air Rifle match was our best. Tim was 1st Sharpshooter, Taylor was 2nd Expert, Samantha was 4th Expert, Megan was 5th Expert, Chiara was 6th Expert, Scott Franz was 9th Expert, and Bobby was 10th Marksman. The Ryann, Tim, and Samantha were 1st Expert team; Chiara, Conlan and Bobby were 2nd Marksman team; and Megan, Scott and Taylor took the Bronze medal as the 3rd team overall.
