4. Denise Henry has more than the required number of nominees for the 2008 board of directors.
5. Lee Eihausen reported that the treasury is OK.
6. Art Thayer said that he would work the problems with e-mailing the newsletter to members who have not been receiving them if those members let him know.
7. George Wright said that the committee that is studying the collegiate issue will report at the next board meeting.
8. George Wright introduced three applicants for membership. Each applicant talked of their interest in the club and all were accepted into the club by unanimous vote. The new members are:
Jack Harrier, Harrison Jenkins, and Robert Clark.
9. George Wright brought up a request from a former member who asked that his back ground check be waived. The board will consider his request at the next board meeting.
10. The meeting was adjourned at 7:18 PM.

BOARD of DIRECT CHERRY CREEK GUN CLUB BOARD OF DIRECTORS MEETING
November 30, 2007

Attendees: Wright, Eihausen, Towne, Ormiston, the Henry's, Calve, Thayer, Shearer, Johnston and many guests.

1. The meeting was called to order by George Wright at 7:01 PM followed by the pledge of allegiance to the flag of the U. S. of A.
3. The minutes to the last board meeting were approved as published.
4. Correspondence received included the American Rifleman magazine and a certificate from the NRA recognizing a club in good standing.
5. Clark Calve is still holding one new member's entry card pending the new member taking the safety course.
5. Warren Johnston announced that the next work party would be on December 17.
6. Art Thayer said that he has received two checks from the NRA for NRA membership fees.
7. Lee Ormiston said that there are now 98 bills pending in Congress with the word "firearms" in them. Lee said that 23 of them seem pro-gun.
8. Tom Rodriguez reported that an application for the Civic League is slow in processing and is pending.
9. Denise Henry said that there are 18 names of the ballot for the 2008 board of directors.
10. The secretary read the requirements for Collegiate membership. One question was resolved by a motion that defined a collegiate member as one who holds a current college ID card. George Wright will be the advisor to collegiate members.
11. Don Shearer defined the requirements for range usage for instructors. A motion passed to accept the proposal.
12. Don Shearer said that the issue of the VA using the range is still open and pending.

13. George Wright opened a discussion of an instructor who has not followed the range usage policy. After a discussion, a motion passed to follow the bylaw procedure of contacting the individual to notify him of the alleged infractions.
 14. The old Corby system which had been listed on the Craig's list and had no response was discussed. A motion passed to place the listing on E-bay.
 15. The board discussed the club's liability and casualty insurance. More research is needed.
 16. The board discussed sending a board member to the next NRA Annual Meeting.
 17. A motion was passed to pay for the materials for the Range Officer's instructor course. The cost would be \$274 total.
 18. A member asked for range usage time for approximately eleven air rifle shooters. The request must be made in writing to the board.
 19. The meeting was adjourned at 8:27 PM.
