6. Lee Eihausen reported that all bills are paid and that there is some paint for the light protection plates and the backstop.
7. Art Thayer reported resolving the method of sending out the newsletter via e-mail.
8. Gary Trisdale said that the Juniors did very well at the last match.
9. Chuck Towne reported that the turning target problem in the west range has been fixed.
10. George Wright said that the Corby system will be listed on Ebay.
11. Don Shearer asked that the activities leaders need to send him an year end financial report which is needed for preparation of the income tax report. The request will be placed in the newsletter.
12. George Wright introduced five applicants for membership. Each applicant talked of their interest in the club and all were accepted into the club by unanimous vote. The new members are: Danny Walker, David Loos, Allen Chee, Rebecca Wardt, and Stacie Biava.

Lee talked about three: HR3305 which provides that no agency of the government shall prohibit any pilot, copilot, or navigator or any law enforcement personnel from carrying a firearm; HR1022 Assault Weapons Ban and Law Enforcement Protection Act of 2007; and HR 2640 NICS Improvement Amendments Act of 2007.
  7. George Wright said that the update of the club’s casualty insurance is pending.
  8. George Wright read a letter from a member offering to build a portable bullet trap for use by those members who wish to reuse their own projectile lead. The 2008 board will consider the request.
  9. The Board elected the following officers for the 2008 board:

    - Vice President – Don Shearer
    - President – George WrightGeorge appointed the heads of the various committees and activities.
  10. The board discussed ways of getting the members to work some of the maintenance items like the periodic repair of the rifle tube backstop.
