Notice!!!! A reminder that the 2013 renewal forms have been sent out !!!!

There has been an important change in the membership categories. Military and Collegiate memberships no longer exist for the 2013 year. Members who are currently in one of those two categories will have to renew as a regular member and include the \$60.00 work bond fee which can be worked off. The total membership dues will be \$260.00. We apologize for any inconvenience this may cause.

2013 Renewals:

1. Please verify the dues amount is correct based on the type of membership that you have and remember to include the locker fee if it applicable.
2. Make sure that your NRA membership is current as of December 31, 2012
3. Sign the form at the bottom of the page.
4. Mail the renewal form and payment to the address at the top of the form or, place the form and the payment in an envelope and put it in the slot on the door of the safe at the Club.
5. **Deadline for membership renewal is December 31, 2012.** Renewals received after the deadline will be assessed a late fee of one-half their membership fee.

NRA Membership Reminder If your NRA membership is about to expire please renew it. All MEMBERS MUST BE NRA MEMBERS. This is necessary to ensure compliance for legal and insurance purposes. This will make renewing the Club membership at the end of the year a lot easier. If your NRA membership has expired your Club membership renewal cannot be processed.

2700 Matches. The matches will be held on Saturday of the last full weekend of each month except for November, when the match will be held on the 17th due to the Thanksgiving holiday. The East range will be reserved for these matches, from 0600 to 1800 hours on each scheduled day. CCGC members may use the West range during these matches. CHERRY CREEK GUN CLUB GENERAL MEETING MINUTES
October 12, 2012

The general membership meeting for the month of September, 2012 was held as scheduled on October 12, 2012 at the club house.

President Jim Bailey called the meeting to order at 1900 followed by the pledge of allegiance.

Comments by Club Members: There were no comments from the floor.

BOARD MEMBER REPORTS:

1. Alan Montoya: reported that the key card system is down, new members will not be able to access the inner door until it is fixed. Anyone interested in qualifying in the tube should sign up. The signup sheet is on the door to the tube. Qualifications are on Friday. If no one signs up he will not plan to be there. Damage to the tube has again been minimal. Thanks to those who are making an effort to shoot accurately.

2. Lee Eihausen: reported the following expenses for the Club this month: Utility bills for last month totaled \$1,600.00. The Club has about \$60,000 in the bank.

Guest Fees for the last two weeks totaled \$651.00.

3. Jack Orischak: reported nothing new.

5. Tom DeHerrera: reported that he is still looking into acquiring two spotting scopes for the tube.

6. Joe Lima: reported that 85 members have already renewed for next year.

7. Jim Bailey: reminded everyone that the work party will be October 20th.

Report on Committees: Bill Davis the chairman of the Nominating Committee reported there have been a number of responses to run for the BOD. Names and their reasons for running will appear in the next newsletter.

The Board of Directors report:

1. Jack Orischak reported that the Arvada Gun Club will be closing their range on December 15th and that it might be an opportunity to recruit some new members. He is going to talk to their President to see if they would announce it in their newsletter.

He mentioned that there are items in the storage shed that have been sitting there unused for a long time, and suggested that some of the items might be sold, specifically mentioned were the old range lights, and the old surveillance equipment. It was suggested that they be offered to the members of the Club first before posting the items elsewhere.

2. Lee Eihausen Collected \$420.00 guest fees for the last two weeks. Comcast has still not installed the second phone line necessary to access the card key system.
3. Gary Trisdale informed us that the Juniors had their first match at the Olympic Training center and did quite well. A couple of new Juniors show up each week.

5. Joe Lima Reported that the next newsletter will contain the information provided by the prospective candidates for the BOD.

7. Tom DeHerrera reported that he purchased one spotting scope to mount in the tube. He was happy with the quality of the scope and purchased and installed two more. He asked that people using them, take care of them.
