**Do you want to continue loading more than one round?** The Board made a rule change pertaining to shooting in the rifle tube. A member may now load up to 10 rounds in the magazine of their rifle. The rest of the rule still applies. **Shoot one, Spot one.** This is a temporary rule change and will be in effect until January 1, 2013 at which time damage to the tube will be assessed. **Extension of the rule will depend on the amount of damage that has occurred. So far the damage has actually increased.** Many members have expressed their approval of this change. If you want the rule to continue beyond the first of the year, members using the tube must be more careful and ensure that their rounds are on target. Please shoot responsibly and encourage others to do so also.

**TUBE NEWS:** From Alan Montoya. For the members who use the rifle tube, there is a new book just inside the door. The book has three partitions to it, the first is for guest to sign in to use the tube, the second is for reporting damage and noting repairs that need to be made to the tube, the third is for any comments that people would like to make about the tube.

Some members have been shooting their rifle with either their iron sights or their scope zeroed in for a distance greater than 100 yards. Since the middle of July there have been 20 hits in the tube from the 30 yard line, all the way down to the five yard line. All of these hits have been in the area from 11 o'clock to the 1 o'clock position. Whoever is doing it please cease. This is too many, in too short a time period to be accidental.

## CHERRY CREEK GUN CLUB GENERAL MEETING MINUTES

August 10, 2012

The general membership meeting for the month of August, 2012 was held as scheduled on August 10, 2012 at the club house.

Present: Jim Bailey; Jack Orischak; Lee Eihausen; Alan Montoya; Gary Trisdale; Jack Priest; Clark Calve and Joe Lima.

Absent: Tom DeHerrera; Warren Johnston; Jack Johansen; Jim Enos was excused.

President Jim Bailey called the meeting to order at 1900 followed by the pledge of allegiance.

**Comments by Club Members:** There were no comments from the floor.

### BOARD MEMBER REPORTS:

1. Mr. Allan Montoya reported that there were no qualifications performed in the tube last month and if anyone was interested in signing up to please do so for the next scheduled qualification. He also reported that someone had put a dozen new holes in the tube, and speculated that it appeared the shooter's rifle was sighted in at a much greater distance than 100 yds, since the holes were in the 11:00 to 1:00 O'clock position. One of the ceiling lights had also been hit. It was once again stressed that the tube rules must be followed to prevent this type of damage.
2. Mr. Lee Eihausen reported that the clubs Excel bill for last month was \$1,600.00. The water bill was \$322.00. The high water bill may be attributed to the floats on the evaporative cooler needing adjustment.
3. Mr. Gary Trisdale had nothing new to report.
4. Mr. Jack Orischak reported the extension of the irrigation system is nearly complete. Kim Duleff and Steve Huda have done a great job and have put in a lot of hours getting the job done.
5. Mr. Clark Calve had nothing new to report.
6. Mr. Jack Priest reported that he and Jack Orischak are in the process of finalizing the proposal to allow Carbines that shoot pistol rounds to shoot on the pistol range. **NEW BUSINESS:** No new business was introduced.

**Unfinished Business:** Bill Davis, chairman of the 2012 Board of Directors Nominating Committee, presented the process which the committee will use in the selection determination. The committee includes Carlton Steubing and Gary Trisdale.

Jim Bailey read the application for membership. There was one new member applicant, Philip Cheney. He spoke of his interest in the club, and his experience with firearms and the sport of hunting, and told a little about himself. A vote was taken by the attending membership and he was accepted to the club. It was explained to him that there would be a pistol range orientation right after the general membership meeting.

The meeting was adjourned at 1920.

## CHERRY CREEK GUN CLUB BOD MEETING MINUTES

August 31, 2012

The meeting was called to order by President Jim Bailey at 7:00 PM followed by the pledge of allegiance to the flag.

Absent: Tom DeHerrera and Warren Johnston

There were no comments from the floor:

The Board of Directors report:

1. Clark Calve had no comment.
2. Jack Orischak reported that the irrigation system is about 98% complete thanks in large part to all the work done by Kim Duleff.
3. Lee Eihausen reported guest fees of \$195.00 and \$310.00 for the last two weeks.
4. Alan Montoya reported two members qualified in the tube and that in the last couple of weeks the damage to the tube has been much less.
5. Jim Enos asked if there was still an interest in obtaining quotes for new surveillance equipment since the old quotes are no longer valid. Since the equipment is working it was decided that nothing needs to be done immediately, but the cameras may be upgraded as needed.
6. Jack Priest brought up the issue of carbines that shoot pistol ammunition. The topic was deferred to unfinished business
7. Gary Trisdale informed us that the Juniors were doing well and there were a couple of new members. A couple of the "old" Juniors have left for college and one received a scholarship to the University of Fairbanks.
8. Jack Johansen said he has recruited a couple of new members.
9. Joe Lima reported that the internet connection has been down due to a severed cable. It has been repaired and remote access to the Security System is once again functioning.

The website has been corrupted and something needs to be done to either repair it or seek a new website host.

Renewals will be sent out next month.

New Business:

1. Gary Trisdale requested the continued use of the East range on Wednesdays from 5:00 P.M. to 8:30 P.M. for small bore practice. The request was granted.
2. Jack Orischak requested the BOD grant a Life Membership to a long time member who has unselfishly performed a great deal of work for the Club. The proposal was discussed and it was decided that written documentation should accompany the request and be presented at the next BOD meeting.

### Unfinished Business:

Jack Priest again presented a motion for the use of Carbines on the pistol range. The following rules would apply:

1. Only 45ACP, 45 Long, 38 Special, 40 S&W and 9mm will be allowed at this time.
2. Absolutely no "bottleneck" cartridges including rimfire.
3. Absolutely no magnum rounds including rimfire.
4. Signs will be posted prominently with these regulations.
5. There will be a sixty day trial period. If members are unwilling to comply with these new rules they will be rescinded.

Concern was expressed about the compliance of the rules, and damage to the steel plate if members used unapproved calibers.

The motion was seconded and passed.

A motion to adjourn was made and seconded.

The meeting was adjourned at 8:00 PM
